# Continue Monitoring COVID updates on ECU's Coronavirus site

All adaptations and announcements due to the COVID-19 situation are posted on ECU's main Coronavirus Update website. The university's main COVID-19 website is where you should go to keep up-to-date on university announcement, contact numbers for the Call Center and more. Make sure to review the LATEST INFO box on that page to see the most recent updates or announcements. That website also provides links to more information about COVID-19 such as how to protect yourself and updates for travelers.

### **On-Campus Research Activities**

Graduate students who are graduating within the calendar year and need to conduct research activities on campus should speak with their research mentor about possible arrangements. The Research and Sponsored Programs Continuity Guidance website offers information about how research programs may be continued or adapted. Graduate students should speak with their research mentors to determine if their work requires submission of the Laboratory Continuity Research Plan or a Critical Activities Request Form. Graduate students should not return to campus to conduct research activities unless one or both of these forms are completed and approved. Your faculty research mentor will submit these on behalf of the student to the Department Chair and Associate Dean for Research for approval and permission to proceed.

ECU Students: Online Tools and Resources for Remote Learning

Students can use the <u>Virtual Computing Lab</u> to access software packages and software is available for download at <u>download.ecu.edu</u>. All students have access to <u>web</u> <u>conferencing tools</u> and a variety of <u>other technology resources</u>.

The IT Help Desk is providing support online and can be reached at 252-328-9866 or 800-340-7081, or through online chat or by submitting a ticket.

The <u>University Writing Center</u> will remain fully online for all Summer Sessions. Refer to their <u>Frequently Asked Questions</u> document for more information. They have 2 types of appointments: **eTutoring** and **chat**. For eTutoring, students upload their papers and receive feedback by email; you don't need to be online for that service. Students can sign up for chat appointments if you would like a conversation in real-time with a writing consultant.

# MAJOR CHANGE TO THESIS & DISSERTATION SUBMISSION PROCESS

### May 4 - Deadline for Submision of Thesis & Dissertation Documents for Spring 2020 Graduation

The deadline for submission of Theses and Dissertations for Spring 2020 has been extended to May 4, 2020 due to the COVID-19 situation. The process for submission has been simplified but formatting guidelines have not changed.

Instead of uploading your document into the Vireo portal, all students submitting a Master's Thesis or Doctoral Dissertation will email three required documents as PDFs (no other formats accepted):

- 1) the Master's Thesis or Doctoral Dissertation
- 2) the NEDL (Non-Exclusive Distribution License) for ECU and ProQuest License Agreement. Please review the licenses, embargo, and access settings. Your online signature is required in the NEDL for ECU and ProQuest. Your thesis/dissertation Director's online signature is required in the NEDL for ECU.
- **3)** Signature Page with signatures. Templates are provided on the Vireo LibGuide. Use the appropriate one: thesis OR dissertation. All forms of electronic signatures/images will be accepted in the separate signature page. You do not need to obtain the signature of the Dean of the Graduate School before you send the email.

Please follow all formatting and style directions on the Lib Guide website. For the remainder of this semester, you will not be using Vireo, even though the webiste has Vireo in the URL and on the title of the page. Instead, you will be submitting/emailing these three documents to *Marquerite Bond (bassm@ecu.edu)* and *T. McConnell (mcconnellt@ecu.edu)*. Be sure to include both those email addresses and you can copy yourself, as well. No paper copies of theses or dissertations will be accepted. No electronic theses or dissertations (ETD) submitted through any service (like Vireo) will be accepted either.

The thesis/dissertation emailed to the ECU Graduate School **must be the final-approved** version by your thesis/dissertation student advisory committee. Please review the deadlines for all upcoming semesters. NOTE: The email submission process is only for Spring 2020 at this time.

#### Important Academic Changes

Here is a summary of some of the most important deadline changes that have occurred this week. They are likely to affect nearly all graduate students.

- Thesis & Dissertation Due Date for Spring 2020 graduation is now May 4, 2020. Please read page 5 carefully for revised submission procedures. Do not use the Vireo portal.
- Withdrawals from courses are being approved through the end of the term. Please review page the Course & Term Withdrawals section of page 7 for information on how to withdraw
- Last day for your faculty to submit a grade to complete an Incomplete course from Spring 2019 has changed from April 28 to December 7, 2020. It is the student's responsibility to contact the course instructor to make arrangements for finishing an course when an Incomplete "I" is assigned.
- The university instituted a Pass/Fail option for most graduate students. Allied Health, Nursing, Dental, and MD programs do not have this option. Please review the COVID-19 update page for information on the pass/fail option. Students will get to review grades in May and will have until June 30th to change them to Pass/Fail if you prefer. You can choose one course or all. Speak with your program adviser about the ramifications of pass/fail if you have questions. You cannot undo the switch to pass/fail if you choose to take it. Once the grades are eliminated and replaced with Pass or Fail, they cannot be changed back.

### REGISTER FOR SUMMER & **FALL NOW!**

### Are You Registered For Summer Course and Term Withdrawals and Fall Yet?

Early registration for summer & fall is open to all students at this time. We recommend you be registered by the end of the week so that your summer bill can be posted to your account and you can begin to make arrangements for payment.

All currently enrolled graduate students are eligible to register for Summer Session 1 or 2, 11-week summer session, and/or Fall semester. Students with holds have to clear those holds first.

**How Do I Register?**Currently enrolled students may use Banner Self Service through Pirate Port to register for courses. Your official schedule must be checked via Banner Self Service each semester. It is the student's responsibility to ensure your schedule is accurate each semester including correct course name, number, section number, and number of credits. To learn more about using **Banner Self Service** for earl; y registration, review the helpful guides on the Registrar's website. Graduate students do not need registration PINs.

### **How Long is Add/Drop Period?**

At ECU, the "add/drop" period is called the Course Adjustment Period and the last date for course adjustments is in the academic calendar for each semester. Students are responsible for adding & dropping courses by this deadline. It is the 5th day of classes in the Fall & Spring Semesters and is typically the 2nd day of classes in summer sessions. Consult the academic calendar for each semester's deadlines.

Courses are rarely added to a student's schedule after the Course Adjustment Period has ended. If this is requested and permitted, the student will be required to pre-pay all tuition & fees. Late requests should come from the Graduate Program Director to the Registrar and Graduate School. The policy on schedule changes is always in the Graduate Catalog.

Any course "dropped" after course adjustment period deadline is not a drop - it is a course withdrawal and a W is listed on the transcript. It is important to consult with your advisor prior to withdrawing from any course and ensure you make withdrawal decisions prior to the deadline each semester. This year due to COVID-19, the Spring withdrawal date has been extended through the end of the semester.

Term withdrawals occur when a student withdraws from all courses in a semester. It is the student's responsibility to email the Registrar, course instructors, and program directors to notify them of this action. The withdrawal policy and procedures are explained in the Graduate Catalog. Withdrawals, either course or term, may affect assistantships, financial aid, and eligibility for student health insurance. Students may consult with graduate program directors, academic advisors, and/or the Dean of Students Office to discuss the impacts of course or term withdrawals. To withdraw, your email is sent to regis@ecu.edu and make sure to include your Banner ID and all the information about the course.

#### ONCE YOU ARE REGISTERED.....

Remember to check your schedule to ensure you have the right courses, section numbers, and number of credits. Fix this now rather than later.

Review the Cashier's website for Tuition and Fees Information as well as the Important Dates calendar. This calendar provides the dates when schedules will be cancelled for non-payment. For example, all bills for Summer 1 and the 11-week Summer Term must be paid by May 13th at 5:00 PM or your schedule could be cancelled and you may not be able to get seats in your classes if there is a waiting list. Please review the Important Dates calendar carefully!
