- 3. Approval of GCC minutes
 - a. October 2, 2013 Approved

- 4. Election of Vice Chair Graduate Council

Significant discussion followed a brief presentation by Prof. Morehead, especially around the idea of requiring an external reader on doctoral dissertation committees

- External reader would be a representative of the Graduate Faculty and a member of the committee from the beginning and continue to the end
- External to the field but not external to the university
- Department would submit approval for reader to Dean of the Graduate School

- Concerns were expressed that this would require too much additional time for faculty to serve as an external reader in addition to other duties and cause unnecessary delays for students in the dissertation defense and approval process
- Dr. Andrew Morehead will request additional comments from graduate program directors which will be brought back to the Graduate Council for further review
- b. Faculty Mentor Awards
 - Monetary funding for these awards is still uncertain at this time
 - The Graduate School will proceed with these awards regardless of the availability of funds
 - Qualtrics survey for entering nominations has been created
 - If Faculty Mentor candidate is re-nominated, information is automatically pulled
 - Paul Gares, Melanie Duffrin, Thom Croskery, and David Taylor have volunteered to serve. One additional student is needed.
 - Nominations for two awards will be solicited one at the doctoral level and one at the master's level
