- Having heard no objections from the Institutional Effectiveness Council Dr. Gemperline will forward the GSAB recommendation to the Academic Council
- 12 to 13 certificate programs have not submitted assessment plans
- The next Graduate Council meeting will be held on October 24th (location TBA)

5. Discussion items:

- Graduate enrollment declined this year (down 400 students) causing concern
 - Largest decline in the College of Education and by non-degree students (in areas of teacher training)
- GRE verbal scores of admitted and enrolled students have risen
- Dr. Gemperline has developed 4 strategies as part of an action plan to increase graduate enrollment
 - Increase number of applications (turn incomplete applications into completed applications)
 - Develop a marketing strategy highlighting cost-benefit (tuition is lower at ECU than at UNC-G and UNC-Charlotte)
 - Develop communication plans to add personal touch (encourage to apply, offer financial incentives if they are available) to the application process
 - Retention strategies

Comments:

- Faculty numbers down in several colleges
- Assign mentors to students admitted by exception
- Cycling cohorts skew numbers
- Retention strategies for enrolled students might include shifting difficult courses until later in the program of study when students have experienced escalating levels of commitment

- First Year Grad Student Survey
 - Survey aimed at assessing program climate, mentoring, support services within the department etc.
 - Pilot survey results will be distributed at a future Graduate Council meeting
- Leadership series for Grad Students
 - First speaker will be Al Delia, Senior Advisor to Governor Perdue, and is tailored to graduate students with an interest in policy development at the local, state, and federal levels
 - The Graduate School is developing a 4 part leadership series for Spring 2012 semester
 - o Former Chancellor Eakin will be the first speaker in Jan. 2012
 - 2 sessions will be held on East Campus and 2 sessions on West Campus
 - Promotional campaign for the 4-part series will begin in November
 - Program will be open to all students
